

  - 2. Designing, constructing / installing of Contactless Hand washing Station of Stainless Steel (minimum Grade 304) through EPC Mode along with Water storage tanks.
  - 3. Water connection at Contactless Hand washing Stations shall be in the scope of the contractor.
  - 4. Total 65 numbers of Contactless Hand washing Stations units will be installed. Bidder shall identify the locations with the discussion with the Engineer in-Charge of BSCL. However, should there be a requirement for any further survey work, and then the contractor shall be liable to get it done at his own cost.

- The sensor of the tap and the dispenser must be Li-ion Battery operated.
- The Unit should have some locking facility to protect the unit from theft.
- The Tank should be covered with SS and combined as a single unit with Tap, Dispenser, sink etc. It should have aesthetic look. The Defect Liability period (replace / Renew any defective portion) is of One-Year from date of completion of the project.
